## **Regional consultation process**

HOW WILL THE GOVERNMENT OF QUÉBEC ENSURE THAT THERE IS A FAIR REPRESENTATION OF THE POPULATIONS AT THE CENTRAL NEGOTIATING TABLE?

The following text will help you understand all of the steps in the regional participation process leading up to the signing of an agreement between the Innu, the Government of Québec and the Government of Canada.

Within the context of the negotiations with the Innu, the Government of Québec has set up a team to ensure that the populations of the Saguenay–Lac-Saint-Jean and Côte-Nord regions are kept informed and are consulted on the discussions under way, and that these populations will have the opportunity to assert their interests at the negotiating table. To facilitate their participation, a regional consultation process has been set up on their behalf.

### **STEP ONE:**

#### **Regional organizations will have their say**

The final text of an eventual treaty has yet to be determined, whether from the standpoint of the content or that of the complementary agreements, in particular concerning the questions related to the territory, taxation and Innu Aitun (traditional activities).

Discussions will continue at the central negotiating table until the final agreement is reached. Not only will the populations of the Saguenay–Lac-Saint-Jean and Côte-Nord regions be represented at the negotiating table, they will also be met

with and consulted on a regular basis by the regional representation teams to give them the opportunity to comment more explicitly on certain elements that will be the subject of discussions over the upcoming months. In some cases, preliminary consultation documents will be produced and submitted to these populations for analysis.

The organizations directly affected by a specific theme will be contacted and met with, if necessary, by the regional representation teams during special information and consultation sessions.

At the request of the regional teams, other information meetings may be held with the participation of government authorities representing Québec and Canada. The purpose of these meetings will be to address precise needs related to the progress and the results of the negotiations under way.

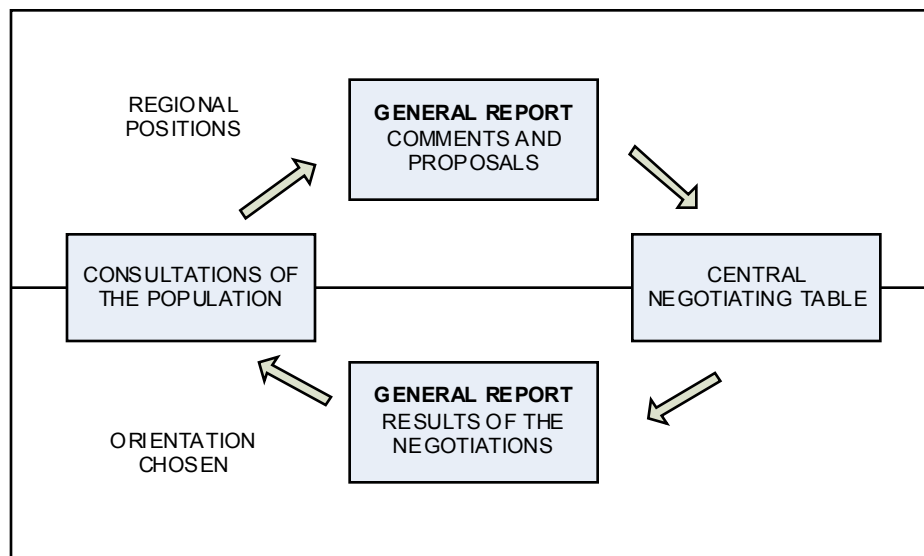
### **STEP TWO:**

#### **Regional representation teams will submit a report**

Once the meetings have been held, each regional team will record the proposals and comments in a general consultation report that will contain, among other things:

- the recommendations presenting the regional positions;
- the summary consultation documents listing the main comments and proposals;
- the reports of the meetings held in the regions.

The representative of the region will send his consultation report to the negotiator for the Government of Québec, the regional authorities, as well as to those organizations that request a copy. The reports will contain invaluable information that will contribute to strengthening the position taken by Québec's negotiating team.



### ***STEP THREE:***

#### **The negotiating table will make its position known to the regions**

Throughout the work leading up to the signing of the treaty, the regional representation teams will inform the Saguenay– Lac-Saint-Jean and Côte-Nord regions of the orientations decided upon at the negotiating table.

However, should a decision made at the negotiating table raise concerns among the populations in question, the representative of the regions will be able to inform the negotiator for Québec or the Minister for Aboriginal Affairs, as the case may be. However, it will be up to the Cabinet to make the final decision as to the outcome of the negotiations.

##### ***Regional consultations: preliminary assessment***

It was on the “good neighbour” theme that the Saguenay–Lac-Saint-Jean and Côte–Nord regions kicked off the regional consultations that will accompany the negotiating process with the Innu communities. Between now and the end of December, several organizations and interest groups will have the opportunity to express themselves and voice their expectations. Whether this involves political authorities at the regional (regional conferences of elected officials, RCMs) or local (municipalities) levels, socioeconomic partners or sectoral stakeholders, everyone will have access to accurate information and will benefit from an efficient liaison mechanism.

Effective immediately, we are available to take part in exchanges or information meetings on a specific aspect of the agreement that is a concern for your organization. The results of this first consultation initiative will be especially important as they will allow us to gauge your interest in this matter as well as the level of mobilization generated by the negotiations with the aboriginal communities. Moreover, these results will guide the regional team in the preparation and improvement, if necessary, of the regional communication and consultation process.
